License Agreement for the use of Argonaut data storage system. IMPORTANT

If you do not accept the terms of this License Agreement for the use of the Argonaut data storage system (the "Agreement"), you cannot use the Argonaut data storage system.

Read this Agreement carefully before using the Argonaut data storage system and additional documentation ("Terms of Service for Technical Support and Agreement for the Provision of Technical Support Service" (Technical Support Agreement)). By starting to use the Argonaut data storage system, you agree to these terms and conditions, and this Agreement between you (the "Licensee") and Argo Technologie SA (the "Licensor") enters into force.

# 1. Scope of the license

The Licensor grants and the Licensee accepts a non-exclusive license for installation, configuration and service of Argonaut data storage systems on one or more servers, depending on the data storage specification and only for the storage volume specified in such specification. The validity period of the Argonaut data storage system license is equal to the term of the paid Technical Support Agreement. The Licensee undertakes not to copy, reproduce or allow others to copy or reproduce the Argonaut data storage system or any parts of it thereof.

#### 2. Ownership and restrictions

- (1) The licensor or its suppliers owns all copyright and proprietary rights to the Argonaut data storage system. The structure, organization and code contained in the Argonaut data storage system are valuable trade secrets of the Licensor and its suppliers. The License to use the Argonaut storage system is also protected by US copyright law and international treaties. The Licensee must treat the Argonaut storage system in the same way that the Licensee would treat any other copyrighted material, such as films or music.
- (2) The Licensee may not copy, lease, distribute, transfer or otherwise use the Argonaut data storage system or any of its parts without the permission of the Licensor.
- (3) The Licensee agrees not to modify, translate, engineer, decompile or reverse-assemble the Argonaut data storage system or any part of it.
- (4) Licensee agrees not to change the file names or the files themselves when accessing the operating system or parts of it.
- (5) The Licensor does not grant the Licensee any rights to the intellectual property of the Argonaut data storage system, its features, the structure, activation system or any other functional or non-functional features.

### 3. Validity period

- (1) This Agreement is valid until the termination or expiration date of the paid Technical Support Agreement.
- (2) The Agreement will be terminated, but without compensation for the unused time of use, if the Licensee decides to terminate it by destroying all installations and distributions of the Argonaut storage system on all servers on which the Argonaut storage system was installed and

the documentation for it, as well as all copies of it in the possession of the Licensee or somehow else related to the Licensee.

(3) Licensor may terminate this Agreement if Licensee fails to comply with the terms and conditions of this Agreement. After termination of the Agreement, the Licensee undertakes to destroy the Argonaut data storage system and its copies or parts of it that are in the possession of the Licensee or under his control.

#### 4. Warranty

LICENSOR AND ITS SUPPLIERS MAKE NO WARRANTIES, EXPRESS OR IMPLIED, REGARDING NON-INFRINGEMENT OF ANY THIRD-PARTY RIGHTS, MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.

### 5. Disclaimer

IN NO EVENT SHALL LICENSOR OR ITS SUPPLIERS BE LIABLE TO OR BE RESPONSIBLE FOR ANY DIRECT, INCIDENTAL, SPECIAL, CONSEQUENTIAL OR EXEMPLARY DAMAGES, INCLUDING BUT NOT LIMITED TO, LOST PROFITS, LOST SAVINGS, OR LOSS OF DATA, EVEN IF LICENSOR HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES AND THIRD-PARTY CLAIMS ARISING IN CONNECTION WITH THE USE OF ARGONAUT DATA STORAGE SYSTEM, EVEN IF THERE IS DELICATE CONDUCT (INCLUDING CERTAIN NEGLIGENCE) OR OTHERWISE.

#### 8. Export restrictions

The licensee warrants that the Argonaut storage system will not be supplied, transferred, exported or re-exported to another country or used in violation of the laws of the USA, EU, Switzerland and or any other applicable export laws or regulations. The licensee undertakes not to export or re-export the Argonaut storage system or its parts or products based on it in any form without a proper license issued by the government of the USA, EU, Switzerland or another country. This Agreement will automatically terminate upon violation of the License.
